Chart 1. Is the budget of the institution published on the web site?





Chart 2. Is the budget of the institution published on the web site? (2019 by type of Public Body)

Chart 3. Is the financial report published on the web site?




Chart 4. Is the financial report for 2018 published on the web site?




Chart 5. Is the institution a first-degree budget spending unit?




Chart 6. Is the institution a first-degree budget spending unit?




Chart 6.1. Are the monthly reports for the execution of the budget published online?




Chart 6.2. Are the monthly reports for the execution of the budget published online? (2019 by type of Public Body)




Chart 6.3. Are the quarterly reports for the execution of the budget published online?




Chart 6.4. Are the quarterly reports for the execution of the budget published online? (2019 by type of Public Body)




Chart 7. Is the institution using program budgeting by the law?




Chart 8. Is the institution using program budgeting by the law?




Chart 8.1. Is the program budget of the institution published?




Chart 8.2. Is the program budget of the institution published?




Chart 8.3. Are quarterly expenditure reports on the program budget published?




Chart 8.4. Are quarterly expenditure reports on the program budget published? (2019 by type of Public Body)




Chart 8.5. Are bi-annual expenditure reports on the program budget published?




Chart 8.6. Are bi-annual expenditure reports on the program budget published? (2019 by type of Public Body)




Chart 8.7. Is an annual expenditures report on the program budget published?




Chart 8.8. Is an annual expenditures report on the program budget published? (2019 by type of Public Body)




Chart 9. Is the institution using program budgeting on its own choice?




Chart 10. Is the institution using program budgeting on its own choice?




Chart 11. Are the payments made through the Electronic State Budget Payments System (SEBRA)²





Chart 12. Are the payments made through the State Electronic Budget Payments System (SEBRA)? (2019 by type of Public Body)

Chart 13. Is a Citizens' Budget published?





Chart 14. Is a Citizens' Budget published?




Chart 16. Is there a Buyer Profile Section on the web site?




Chart 17. Are calls for public procurement tenders published on the web site?




Chart 18. Are calls for public procurement tenders published on the web site? (2019 by type of Public Body)




Chart 19. Is the public procurement tender documentation published on the web site?




Chart 20. Is the public procurement tender documentation published on the web site? (2019 by type of Public Body)




Chart 21. Are the protocols of the public procurement assessment commissions published?




Chart 22. Are the protocols of the public procurement assessment commissions published? (2019 by type of Public Body)




Chart 23. Are public procurement contracts of the institution published on its web site?





Chart 24. Are public procurement contracts of the institution published on its web site? (2019 by type of Public Body)

Chart 25. Is a list of the officials who have submitted conflict of interests and assets declarations available online?




Chart 26. Is a list of the officials who have submitted conflict of interests and assets declarations available online? (2019 by type of Public Body)




Chart 27. Are the conflict of interests and assets declarations published on the web site?





Chart 28. Are the conflict of interests and assets declarations published on the web site? (2019 by type of Public Body)

Chart 29. Is the date of the public discussion on the draft municipal budget published?




Chart 30. Is the draft of the municipal budget published?




Chart 31. Is the date of the public discussion on the Financial annual report on the execution of the municipal budget published?




Chart 32. Is the financial report on the execution of the municipal budget published?
