



Chart 2. Is there an Access to Information Section on the website?

Chart 3. Where is the Access to Information Section located?




Chart 4. Where is the Access to Information Section located?




Chart 5. Is there information about the department responsible for accepting access to information requests?




Chart 6. Is there information about the department responsible for accepting access to information requests? (2017 by type of Public Body)




Chart 7. What type of information is online available?




Chart 8. Is there the name of department? (2017 by type of Public Body)




Chart 9. Is there the adress? (2017 by type of Public Body)




Chart 10. Is there the e-mail? (2017 by type of Public Body)




Chart 11. Is there the telephone number? (2017 by type of Public Body)




Chart 12. Is there the working hours? (2017 by type of Public Body)




Chart 13. Is there the responsible official (2017 by type of Public Body)




Chart 14. Is there explanatory information on how to exercise one's right to information?




Chart 14.1 Where did you find the explanatory information on how to exercise one's right to information?




Chart 15. Is there explanatory information on how to exercise one's right to information? (2017 by type of Public Body)




Chart 16. Is information about the procedure and the conditions for the re-use of public sector information published?




Chart 17. Is information about the procedure and the conditions for the re-use of public sector information published? (2017 by type of Public Body)




Chart 18. Is information about the fees for the re-use of public sector information published?




Chart 19. Is information about the fees for the re-use of public sector information published?




Chart 20. Is information about the norms determining the costs for the provision of access to information published?




Chart 21. Is information about the norms determining the costs for the provision of access to information published? (2017 by type of Public Body)




Chart 22. Are the APIA implementation internal rules published?




Chart 23. Are the APIA implementation internal rules published? (2017 by type of Public Body)




Chart 24. Are the Internal Rules updated in line with the APIA amendments as of December 2015?




Chart 25. Are the Internal Rules updated in line with the APIA amendments as of December 2015? (2017 by type of Public Body)




Chart 26. Where are they published?




Chart 27. Where are they published? (2017 by type of Public Body)




Chart 28. Is the annual report on the APIA implementation published?




Chart 29. Is the annual report on the APIA implementation published?




Chart 29.1. Does it contain data about registered requests?




Chart 29.2. Does it contain data about registered requests? (2017 by type of Public Body)




Chart 29.3. Does it contain data about issued refusals?




Chart 29.4. Does it contain data about issued refusals? (2017 by type of Public Body)




Chart 29.5. Does it contain the grounds for the issued refusals?




Chart 29.6. Does it contain the grounds for the issued refusals? (2017 by type of Public Body)




Chart 30. Is there a description of the procedure for access to the public registers maintained by the respective institution?





Chart 31. Is there a description of the procedure for access to the public registers maintained by the respective institution? (2017 by type of Public Body)

Chart 32. Is a list of the categories of information classified as official secret published on the website?




Chart 33. Is a list of the categories of information classified as official secret published on the website? (2017 by type of Public Body)




Chart 34. Is a list of documents declassified under § 9 of the Protection of Classified Information Act published?




Chart 35. Is a list of documents declassified under § 9 of the Protection of Classified Information Act published? (2017 by type of Public Body)




Chart 36. Is there a list of the categories of information, subject to publication online concerning the sphere of activity of the respective institution?




Chart 37. Is there a list of the categories of information, subject to publication online concerning the sphere of activity of the respective institution? (2017 by type of Public Body)




Chart 38. Is there a section for information provided more than three times at a request?





Chart 39. Is there a section for information provided more than three times at a request? (2017 by type of Public Body)

Chart 40. Are electronic access to information requests accepted?




Chart 41. Are electronic access to information requests accepted? (2017 by type of Public Body)




Chart 42. Is an electronic signature required to submit an access to information request?




Chart 43. Is an electronic signature required to submit an access to information request?




Chart 44. Answer to E-requests




Chart 45. Response way to e-requests




Chart 46. Decisions on the requested information
